1. Why this information

3. Types of data processed, purposes of the processing, and legal bases.

Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. The IP addresses or domain names of the computers used by users who connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment. These data are necessary for the use of the web service.

These data are also used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning, and are deleted immediately after processing.

Data communicated voluntarily by the user

The optional, explicit and voluntary sending of e-mails to the addresses indicated on this site entails the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the communication.

Data recipients

- **Methods of processing and conservation of the data**

The processing of personal data takes place through IT tools suitable to guarantee the security and confidentiality of the data and in any case in compliance with the appropriate security measures as required by art. 32 GDPR.

Cookie Policy

1. Why we are providing you with this information

Pursuant to *European Regulation 2016/679* (hereinafter "RGPD") **BV TECH S.p.A** (hereinafter, "Owner"), as Holder Of data Treatment, provides the following information relating to the cookies installed on the website www.privatewave.com.

2. What are they the Cookies

Cookies are text strings consisting of portions of code sent by a web server (eg a site) to an Internet browser and installed within it. In particular, these are small text files that the websites visited by users send to their terminals, where they are stored before being re-transmitted to the same sites on subsequent visits.

Cookies can be stored permanently on the user's computer or mobile device or have a variable duration (so-called persistent cookies), but they can also disappear when the browser is closed or have a limited duration (so-called session cookies). Cookies can be installed from the site that the user is visiting (so-called first-party cookies) or they can be installed from other websites (so-called third-party cookies).

3. Type of cookies used and purpose

Cookies are used to improve the browsing experience:

- memorizing the settings, so as not to force you to re-enter them every time you visit a new page;

In detail we collect:

Technical Cookies

Technical cookies (for which the user's consent is not required) are used to browse or provide services requested by the user. Without the use of these cookies, some operations could not be performed or would be more complex and / or less secure for the user.

a) *Navigation cookies*

We use navigation cookies to allow users a safe and efficient navigation and use of the Site.

b) *Functionality cookies*

We use functionality cookies for activities strictly necessary for the proper functioning of the Site.

Some of the services listed below based on the functionality offered to Users, focused on the use of third-party cookies, may not require the user's consent. Furthermore, these third parties could - in addition to what is specified in this Cookie Policy and also without the knowledge of the Data Controller - carry out further User tracking activities.
